

Website Privacy Policy

(including Cookie Policy)

We are committed to safeguarding the privacy of our website visitors; this policy sets out how we will treat your personal information. By using our website you agree to this policy.

Our website uses cookies. We will ask you to consent to our use of cookies in accordance with the terms of this policy when you first visit our website.

1. What Information Do We Collect?

We may collect, store and use the following kinds of personal information:

- information about your computer and about your visits to and use of this website *(including your IP address, geographical location, browser type and version, operating system, referral source, length of visit, page views and website navigation)*
- information that you provide to us for the purpose of subscribing to our website services, email notifications and/or newsletters *(including your name and email address)*
- any other information that you choose to send to us

2. Cookies

2.1 About Cookies

A cookie is a file containing an identifier (a string of letters and numbers) that is sent by a web server to a web browser, and stored by the browser. The identifier is then sent back to the server each time the browser requests a page from the server.

Cookies can be used by web servers to identify and track users as they navigate different pages on a website and to identify users returning to a website.

Cookies may be either “persistent” cookies or “session” cookies. A persistent cookie consists of a text file sent by a web server to a web browser, which will be stored by the browser and will remain valid until its set expiry date (unless deleted by the user before the expiry date). A session cookie, on the other hand, will expire at the end of the user session, when the web browser is closed.

2.2 Cookies on this website

We use both session cookies and persistent cookies on this website.

We may send to you the following cookies:

1. *PHPSESSID*
2. *_utmb*
3. *_utmc*
4. *_utmz*
5. *_utmx*

Cookies 1 & 2 are session cookies, whereas cookies 3, 4 & 5 are persistent cookies.

2.3 How we use cookies

Cookies do not contain any information that personally identifies you, but personal information that we store about you may be linked, by us, to the information stored in and obtained from cookies.

We may use the information we obtain from your use of our cookies for the following purposes:

1. *to recognise your computer when you visit our website*
2. *to track you as you navigate our website*
3. *to improve the website's usability*
4. *to analyse the use of our website*
5. *to prevent fraud and improve the security of the website*

2.4 Third party cookies

When you use our website, you may also be sent third party cookies.

Our service providers may send you cookies. They may use the information they obtain from your use of their cookies:

1. to track your browser across multiple websites
2. to target advertisements which may be of particular interest to you

In addition, we use Google Analytics to analyse the use of this website. Google Analytics generates statistical and other information about website use by means of cookies, which are stored on users' computers. The information generated relating to our website is used to create reports about the use of the website. Google will store this information. 2.5 Blocking cookies

Most browsers allow you to refuse to accept cookies. For example:

1. in Internet Explorer you can refuse all cookies by clicking “*Tools*”, “*Internet Options*”, “*Privacy*”, and selecting “*Block all cookies*” using the sliding selector
2. in Firefox you can block all cookies by clicking “*Tools*”, “*Options*”, and un-checking “*Accept cookies from sites*” in the “*Privacy*” box

Blocking all cookies will, however, have a negative impact upon the usability of many websites. If you block cookies, you may not be able to use some areas or features on this website.

2.6 Deleting cookies

You can also delete cookies already stored on your computer:

1. in Internet Explorer, you must manually delete cookie files (you can find instructions for doing so at <http://support.microsoft.com/kb/278835>)
2. in Firefox, you can delete cookies by, first ensuring that cookies are to be deleted when you “*clear private data*” (this setting can be changed by clicking “*Tools*”, “*Options*” and “*Settings*” in the “*Private Data*” box) and then clicking “*Clear private data*” in the “*Tools*” menu

3. Using Your Personal Information

Where you submit personal information for publication on our website, we will publish and otherwise use that information in accordance with the licence you grant to us.

4. Disclosures

We may disclose information about you to any of our employees, officers, agents, suppliers or subcontractors insofar as reasonably necessary for the purposes as set out in this privacy policy.

In addition, we may disclose your personal information:

- to the extent that we are required to do so by law
- in connection with any legal proceedings or prospective legal proceedings
- in order to establish, exercise or defend our legal rights (including providing information to others for the purposes of fraud prevention and reducing credit risk)
- to any person who we reasonably believe may apply to a court or other competent authority for disclosure of that personal information where, in our reasonable opinion, such court or authority would be reasonably likely to order disclosure of that personal information

Except as provided in this privacy policy, we will not provide your information to third parties.

5. International Data Transfers

Information that we collect may be stored and processed in and transferred between any of the countries in which we operate in order to enable us to use the information in accordance with this privacy policy.

Information which you provide may be transferred to countries (*including the United States*) which do not have data protection laws equivalent to those in force in the European Economic Area.

In addition, personal information that you submit for publication on the website will be published on the internet and may be available, via the internet, around the world. We cannot prevent the use or misuse of such information by others.

You expressly agree to such transfers of personal information.

6. Security Of Your Personal Information

We will take reasonable technical and organisational precautions to prevent the loss, misuse or alteration of your personal information.

Of course, data transmission over the internet is inherently insecure, and we cannot guarantee the security of data sent over the internet.

7. Policy Amendments

We may update this privacy policy from time-to-time by posting a new version on our website. You should check this page occasionally to ensure you are happy with any changes.

8. Your Rights

You may instruct us to provide you with any personal information we hold about you. Provision of such information will be subject to:
